STATMENT OF FULFILLMENT OF MINIMAL TECHNICAL REQUIREMENTS

Inspection of premises is conducted only for catering businesses, for both physical and legal persona. This is done through a municipal inspection after submission of request and proof of payment of the municipal administrative tax.

Legal persona require:

- Registration approval certificate for the business issued by the canton court, business with headquarters outside the municipality where they seek to open a branch, it is necessary to register the company into the court registry with regard to Article 2 of the Business Law
- ID tax number
- Proof of ownership of premises or validated contract of landlord
- Usage permission for the premises
- Sanitary booklet
- Assessment on noise reduction
- Administrative tax 55,00 KM
- Other documentation depending on the business type

For other business types the managing director signs a statement declaring the fulfilment of minimal technical conditions .
